

ORDINANCE NO. 12.01.2024

AN ORDINANCE AMENDING THE CODE OF ORDINANCES OF THE CITY OF MARTENSDALE, IOWA
BY AMENDING PROVISIONS PERTAINING TO WATER SERVICE RATES

BE IT ENACTED by the City Council of the City of Martensdale, Iowa:

SECTION 1. Chapter 92, Section 02 of the Code of Ordinances of the City of Martensdale, Iowa, is repealed and the following adopted in lieu thereof:


92.02 Rates and Services. Water service shall be furnished at the following monthly rate within the City:

- A. Beginning February 2025, the monthly rate shall be as follows:
1. First 2,000 gallons used per month at \$44.00 (minimum bill).
 2. All over 2,000 gallons used per month at \$11.50 per 1,000 gallons.

SECTION 2. SEVERABILITY CLAUSE. If any section, provision or part of this ordinance shall be adjudged invalid or unconstitutional, such adjudication shall not affect the validity of the ordinance as a whole or any section, provision or part thereof not adjudicated invalid or unconstitutional.


SECTION 3. WHEN EFFECTIVE. This Ordinance shall be in effect from and after its final passage, approval and publication as provided by law.

ORDINANCE NO. 12.01.2024.1

AN ORDINANCE AMENDING THE CODE OF ORDINANCES OF THE CITY OF
MARTENSDALE, IOWA PERTAINING TO SANITARY SEWER AND RENTAL RATES

BE IT ENACTED by the City Council of the City of Martensdale, Iowa:

SECTION 1. The Code of Ordinances of the City of Martensdale, Iowa, is amended by changing sanitary sewer surcharges and rental rates in Chapter 99, Section 02 which is hereby adopted to read as follows:

99.02 SURCHARGE AND RENTAL RATES.

Each user of the municipal sanitary sewer system shall pay a \$6.49 per month sanitary sewer fee.

Each user of the municipal sanitary sewer system shall pay a sanitary sewer service charge for the use of and for the service supplied by the municipal sanitary sewer system based upon the amount and rate of water consumed as follows:


1. From and after the 1st of February 2025, the first 2000 gallons used per month shall be \$47.00 per month (minimum monthly bill). All water usage over 2,000 gallons used per month shall be charged at a rate of \$8.00 per 1,000 gallons.

SECTION 2. REPEALER. Ordinances or parts of Ordinances in conflict with the provisions of this Ordinance are hereby repealed.

SECTION 3. SEVERABILITY CLAUSE. If any section, provision or part of this ordinance shall be adjudged invalid or unconstitutional, such adjudication shall not affect the validity of the ordinance as a whole or any section, provision or part thereof not adjudicated invalid or unconstitutional.


SECTION 4. WHEN EFFECTIVE. This Ordinance shall be in effect from and after its final passage, approval and publication as provided by law.

AN ORDINANCE AMENDING THE CODE OF ORDINANCES OF THE CITY OF MARTENSDALE, IOWA
BY ADDING PROVISIONS PERTAINING TO A WATER TOWER MAINTENANCE FEE

BE IT ENACTED by the City Council of the City of Martensdale, Iowa:

SECTION 1. The Code of Ordinances of the City of Martensdale, Iowa, is amended by adding a new Section 92.11, entitled Water Tower Maintenance Fee which is hereby adopted to read as follows:

92.11 WATER TOWER MAINTENANCE FEE.

Each user of the municipal water system shall pay a water tower maintenance fee for each water meter in the sum of \$9.00 per month.

SECTION 2. REPEALER. Ordinances or parts of Ordinances in conflict with the provisions of this Ordinance are hereby repealed.

SECTION 3. SEVERABILITY CLAUSE. If any section, provision or part of this ordinance shall be adjudged invalid or unconstitutional, such adjudication shall not affect the validity of the ordinance as a whole or any section, provision or part thereof not adjudicated invalid or unconstitutional.

SECTION 4. WHEN EFFECTIVE. This Ordinance shall be in effect from and after its final passage, approval and publication as provided by law.

BE IT ENACTED by the City Council of the City of Martensdale, Iowa:

SECTION 1. The Code of Ordinances of the City of Martensdale, Iowa, is amended by adding a new Section 99.09, entitled Sewer Maintenance Fee which is hereby adopted to read as follows:

99.09 SEWER MAINTENANCE FEE.

Each user of the municipal sanitary sewer system shall pay a sewer maintenance fee in the sum of \$9.00 per month.

SECTION 2. REPEALER. Ordinances or parts of Ordinances in conflict with the provisions of this Ordinance are hereby repealed.

SECTION 3. SEVERABILITY CLAUSE. If any section, provision or part of this ordinance shall be adjudged invalid or unconstitutional, such adjudication shall not affect the validity of the ordinance as a whole or any section, provision or part thereof not adjudicated invalid or unconstitutional.
